- ☐ Bunk top covers (*panelen naast de mast*)
- ☐ The guard wire (*relingdraden*) shall not deflect more than 50mm with a force of 5 kg

- ☐ Boom band distance (*E-maat*) max. 3810 mm
- ☐ ICA royalty label mainsail (*sailtags*)
